## Romania Constitution

my version

### ARTICLE 1

(4) The State is organized based on the principle of the separation and balance of powers -legislative, executive, and judicial - within the framework of constitutional democracy.

(5) In Romania, the observance of the Constitution, its supremacy and the Constitution is mandatory.

### ARTICLE 2

(1) The national sovereignty is reside within the Romanian people, that are exercise it by means of their representative bodies, resulting from free, periodical and fair elections, as well as by referendum.(2) No group or person may exercise sovereignty in one's own name.

### ARTICLE 3

#### Territory

(1) The territory of Romania is inalienable.

(2) The frontiers of the country are sanctioned by the Constitution, with the observance of the principles and other generally recognized regulations of international law.

(3) The territory is organized administratively into communes, towns and counties.

(4) No foreign populations is displaced or colonized on the territory of the Romanian State.

### ARTICLE 4

#### Unity of the people and equality among citizens

(1) The State foundation belongs to the Romanian people and the solidarity of its citizens.

(2) Romania is the homeland of all its citizens and people, without any discrimination on account of race, nationality, ethnic origin, language, religion, sex, opinion, political adherence, property or social origin.

### Article 5

#### Citizenship

(1) Citizen that are born on Romania soil or person that are naturalize from Romania Clerk or Judge or members of the Parliament have the Citizenship!

### ARTICLE 6

Right to identity

(1) The State recognizes and guarantees the right of persons belonging to national minorities to the preservation, development and expression of their ethnic, cultural, linguistic and religious identity.

(2) The protection measures taken by the Romanian State for the preservation, development and expression of identity of the persons belonging to national minorities is conform to the principles of equality and non-discrimination to the other Romanian citizens as equal under the Law.

#### ARTICLE 7

Romanians living abroad

The Romania Country recognize the international Laws as the most highest Laws in The Country as here defined, Declaration of Universal Human Rights and as Lower Law the European Constitution!

#### ARTICLE 8

Pluralism and political parties

(1) Pluralism in the Romanian society is a condition and guarantee of constitutional democracy.

(2) Political parties are constituted and pursue their activities in accordance with the Constitution and here defined International Laws, territorial integrity in principles of democracy as sovereign Country.

#### ARTICLE 9

Every Citizen in the meaning of Natural- and Law-persons have the right to choose free where they are working, how long and with what contract and conditions. Citizens and Persons have also the right to choose free his profession and contract, this al outside the state duty!

#### ARTICLE 10

International relations

Romania is tilted on peaceful relations with all the states, and, in this context, good neighborly relations, based on the principles and other generally recognized provisions of international law.

#### ARTICLE 11

International law and national law

(1) The Romanian State is force to enforce its obligations to the Constitution of Romania and here defined International Law

(2) Treaties ratified by Parliament, according to the Constitution, are part of national law.

(3) If a treaty Romania is to become a party to comprises provisions contrary to the Constitution, its ratification is declared as non-existent!

#### ARTICLE 12

(1) The flag of Romania is tricolor, the colors are arranged vertically in the following order from the flag-pole: blue, yellow, red

(1) All citizens have the rights and freedoms defined from the Constitution and here defined International Law, and have the duties laid down thereby.

(2) Everyone is innocent until by duty of Romania is approved in chain of evidence as guilty.

#### ARTICLE 16

##### Equality of rights

(1) No one is above the Constitution and here defined international laws European Constitution, Universal Declaration of Human Rights.

#### ARTICLE 17

##### Romanian citizens while abroad

Romanian citizens have al rights and duty's defined thru here presented Constitution, European Constitution, Declaration of Universal Human Rights and the duty's defined thru the state, every law defined thru the state that voided the Constitution of Romania is declared automatically as non existent!

##### Aliens and stateless persons

Extradition and expulsion

(1) No Romanian citizen shall be extradited or expelled from Romania against here defined Constitutional and International law.

ARTICLE 21

Free access to justice

(1) Every person have the right to bring cases before the courts for his defense of his legitimate rights to have access to files and liberties and interests.

(2) The exercise of this right shall not be restricted by any law.

(3) All Citizen and all kind of Persons have the duty to a fair trial.

ARTICLE 24

Right to defence

(1) The right to defence is guaranteed.

(2) All throughout the trial, the parties have the right to be assisted by a lawyer of their own choosing.

ARTICLE 25

Freedom of movement

(1) The right of free movement within the national territory and abroad is guaranteed. The law shall lay down the conditions for the exercise of this right.

(2) Every citizen and person of all kind is guaranteed the right to establish his domicile or residence anywhere in the country, to emigrate, and to return to his country.

ARTICLE 26

Personal and family privacy

(1) Natural Persons have the right of all necessary protection and respect of integrity of the own families members.

(2) Any Kind of person have the right of privacy!

ARTICLE 27

Inviolability of domicile

(1) The domicile and the residence are inviolable. No one have the right to enter or remain in the domicile or residence of a person without his agreement.

(2) An exemption from the here presented Constitutional Laws results if all kind of persons act in contradiction of the here defined Constitutional and International Rights what results in losses of rights on the Constitution!

#### Secrecy of correspondence

Secrecy of all kind of letters, telegrams and other postal communications, of telephone conversations, and of any other legal means of communication is inviolable.

#### ARTICLE 29

##### Freedom of conscience

- (1) Freedom of thought, opinion, and religious beliefs shall not be restricted in any form whatsoever.
- (2) Freedom of conscience is guaranteed; is manifested in a spirit of tolerance and mutual respect.
- (3) All religions are free and organized in accordance with their own statutes
- (5) Religious cults have autonomous from the State and shall enjoy support from it, including the facilitation of religious assistance in the army, in hospitals, prisons, homes and orphanages

#### ARTICLE 36

##### Right to vote

- (1) Every citizen having turned eighteen have the right to participate on the election day to vote

#### ARTICLE 37

##### Right to be elected

- (1) Eligibility is granted to all citizens having the right to vote, who meet the requirements in the Constitution ,
- (2) Citizens Candidates must have turned up to twenty-three years of residence in Romania on the election day, in order to be elected to the Chamber of Deputies or the bodies of local public administration, at least thirty-three in order to be elected to the Senate, and at least thirty-five in order to be elected to the office of President of Romania.

#### ARTICLE 39

##### Freedom of assembly

- (1) The freedom of peaceful protesting is guaranteed
- (2) If the Constitution is under threat under the misguided body's of the State and is this voided, the Citizen have the right to bear arms and to defend the Constitution,

#### ARTICLE 40

##### Right of association

- (1) Citizens may freely associate into political parties, trade unions, employers' associations, and other forms of association.
- (2) The political parties or organizations which, by their aims or activity, militate against political pluralism, the principles of a State governed by the rule of law, or against the sovereignty, integrity or independence of Romania shall be unconstitutional.

(3) Judges of the Constitutional Court, the advocates of the people, magistrates, active members of the Armed Forces, policemen and other categories of civil servants, established by an organic law, shall not join political parties.

#### ARTICLE 51

##### Right of petition

(1) Citizens have the right to address the public authorities by petitions formulated only in the name of the signatories.

(2) Legally established organizations have the right to forward petitions.

(3) The exercise of the right of petition shall be exempt from tax.

(4) The public authorities are bound to answer to petitions that are made from 30 % of the state population within the time limits are 6 days. The state have to forward that to parliament if it is that a reason of federal matter.

#### ARTICLE 54

##### Loyalty to the constitution

(2) Citizens holding public offices, as well as the military are force for the loyalty fulfillment of the obligations they are bound to, and are for this purpose, take the oath as requested by Holy Book and the Constitution of Romania!

##### Defence of the Constitution

(1) Citizens have the right and duty to defend the constitution of Romania for inner and outer enemy's

(2) The terms for doing the military service shall be set up in an organic law.

(3) Citizens may be conscripted from the age of 20 and up to the age of 35, except for volunteers, under the terms of the applicable organic law.

#### ARTICLE 56

##### Financial contributions

(1) Citizens are under the obligation to contribute to public expenditure, by taxes and duties.

(2) The legal taxation system must ensure a fair distribution of the tax burden.

(3) Any other dues shall be prohibited, except those determined by law, under exceptional circumstances.

#### ARTICLE 58

##### Appointment and role

(1) The Advocate of the People is appointed for a term of office of 5 years, in order to defend the natural persons' rights and freedoms. The Advocate of the People's deputies is specialized per fields of activity.

(2) The Advocate of the People and his/her deputies shall not perform any other public or private office, except for teaching positions in higher education.
